

NYR Motorized Recreational Vehicle Safety Requirements

Our Goal is to maintain a safe environment while meeting the special needs of campers that arise from the rough terrain of Roundup Ranch. To ensure that NYR remains a safe environment as our attendance increases, the following requirements are mandatory and will be strictly enforced:

1. All recreational vehicles (ATV, UTV, Golf Carts, etc) that are brought to NYR must have a qualified driver who submits the application below and pays appropriate application fees per vehicle.
2. All applications must be reviewed and approved by NYR Leadership.
3. The minimum age of a qualified driver for all recreational vehicles is 21 years of age.
4. A qualified driver must have experience on the vehicle being registered.
5. Only approved qualified drivers may operate registered vehicles indicated by colored wristbands issued by NYR.
6. All approved vehicles must:
 - a. ...remain at low speeds that will not create unnecessary noise, dust or danger.
 - b. ...only be used for essentials (water hauling, disabled transportation, load-in/out)
 - c. ...be driven with sensitivity to the rugged terrain and surrounding pedestrians.
7. Approved vehicles **are not to be** used for recreational purposes on NYR property.
8. To ensure the above safety requirements are maintained, Camp Management, along with the Sheriff and his deputies, will be strictly enforcing them for the benefit of a safe camping environment. All approved qualified drivers must respond with respect with regard to any directives that are given from those put in place by NYR.
9. The authority is given to the Camp Management and Sheriff to revoke the above privileges, without refund of any fees or registration for those who are not operating according to the stated requirements.
